1. Information We Collect

- Name

- Login credentials

This information is kept private and is not shared with third parties.

2. Use of Information

- Displaying, promoting, and distributing supplier listings across the Platform and affiliated industry channels.

We do not use or disclose user login information for marketing purposes or share it with third parties.

- Encryption of sensitive data.
- Secure storage systems for user login information.
- Regular updates to our security protocols.

4. Disclosure of Information

- Remember user preferences.
- Analyse website traffic and usage patterns.

We may use third-party services, such as Google Analytics, to understand website performance. Users can manage or disable cookies through their browser settings.

We retain user login information for as long as necessary to provide our services. When this information is no longer needed, it is securely deleted from our systems.
